Privacy Statement for Applications by Barristers for Admission to the Roll of Solicitors

We are the Law Society of Ireland of Blackhall Place, Dublin 7, Ireland (the "Law Society", "we", "us", "our"). We are the educational, representative and regulatory body of the solicitors' profession in Ireland.

We take our responsibilities under applicable data protection law, including the General Data Protection Regulation ("the GDPR") and implementing legislation such as the Data Protection Act 2018 very seriously. The purpose of this notice is to inform you of the data relating to you that we may collect and use in connection with your application to be admitted to the Roll of Solicitors, and the uses (including disclosures to third parties) we may make of such data.

Personal Data that we collect and Process

We will collect and process personal data relating to you in connection with your application to be admitted to the Roll of Solicitors. This personal data may include:

- your name and contact details, including your address, phone number, email address and post code;
- your date of birth;
- your bank account details (if a refund applies);
- where relevant, information relating to the commission or alleged commission of a criminal offence:
- your educational background and academic qualifications, including details of the Essentials of Legal Practice Course you attended and certified copies of certificates evidencing your professional qualification as a barrister and your higher education academic qualifications;
- a certificate of being in good standing;
- proof that you have passed or been exempted from an Irish language examination;
- a letter of disbarment from the Honourable Society of the Kings Inns;

- proof of you having spent at least six months in the office of a practising solicitors for the purpose of receiving due instruction and obtaining experience in the practice and profession of a solicitor;
- your CCTV data;
- any other personal data which you provide to us directly.

Purposes of Processing and Legal Basis

We will use personal data relating to you for the purposes of:

- assessing your suitability and ensuring you meet the requirements to be entered on the Roll of Solicitors;
- updating and maintaining the Roll of Solicitors and the Register of Practising Solicitors;
- the CCTV monitoring of Law Society premises at Blackhall Place to minimise security and safety risks and to assist in the investigation of security and safety incidents;
- complying with our legal and regulatory obligations;

The legal bases on which we collect, process and transfer your information in the manner described above are:

- that this is necessary for the performance of a contract with you or in order to take steps at your request prior to entering into a contract;
- our legitimate interests in regulating the solicitors' profession in Ireland and ensuring the proper management and functioning of the Law Society. We will not process your personal data for these purposes if to do so would constitute an unwarranted interference with your own interests, rights and freedoms;
- that this is necessary for compliance with a legal or regulatory obligation that applies to us:
- our legitimate interest under Article (6) (1) (f) of the GDPR.

The legal bases on which we collect, process and transfer personal data relating to criminal convictions and offences in the manner described above are:

• that this is authorised by law under the Solicitors Acts 1954 – 2015.

Recipients of Data

We may disclose your personal data to other organisations in connection with the above purposes, including:

• to third parties who we engage to provide services or benefits to us or to you, such as professional advisers, auditors, insurers and outsourced service providers;

- to competent regulatory authorities and other bodies as requested or required by law, including the Judicial Appointments Advisory Board, the Legal Services Regulatory Authority; and
- to members of the public, as required by law;
- to the President of the High Court who signs the Certificate of Admission.

Requirement to Provide Data

You are not under a statutory or contractual duty to provide us with any personal data. However, there are some pieces of information that you must provide to us so that we can process your application to be admitted to the Roll of Solicitors. If you do not provide this information, we may not be able to process your application.

Retention

We will not hold your data for longer than is necessary. We may retain your personal data for the duration of your relationship with the Law Society and for such period of time thereafter as is necessary to comply with our legal and regulatory obligations.

Transfers Abroad

In connection with the above we might transfer your personal data outside the European Economic Area, including to a jurisdiction which is not recognised by the European Commission as providing for an equivalent level of protection for personal data as is provided for in the European Union. If and to the extent that we do so, we will ensure that appropriate measures are in place to comply with our obligations under applicable law governing such transfers. These may include entering into a contract governing the transfer that contains the 'standard contractual clauses' approved for this purpose by the European Commission. Your rights

You have the following rights, in certain circumstances and subject to certain restrictions, in relation to your personal data:

- Right to access the data You have the right to request a copy of the personal data that we hold about you, together with other information about our processing of that personal data.
- Right to rectification You have the right to request that any inaccurate data that is held about you is corrected, or if we have incomplete information you may request that we update the information such that it is complete.
- Right to erasure You have the right to request us to delete personal data that we hold about you. This is sometimes referred to as the right to be forgotten.
- Right to restriction of processing or to object to processing You have the right to request that we no longer process your personal data for particular purposes, or to object to our processing of your personal data for particular purposes.

Right to data portability – You have the right to request us to provide you, or a third
party, with a copy of your personal data in a structured, commonly used machine
readable format.
